Ministerial Update

Ministerial Startup Retreat, 11/16 10:30-12:30, Potluck 12-1:30. Board, etc. afternoon. 1:30-3:30. Tandy Rodgers will facilitate. RACI charts with role clarification in afternoon. Please bring food for potluck. Going to be important to help recast the role of the board as not responsible for operations.

Policy governance with Roger Berchausen, 12/7 10-Noon. Roger is looking forward to meeting with us. Will be a Zoom call, may be better individually rather than all together. Basic Policy Governance info, to be recorded for future Board members. Nothing to read – not a whole lot out there. Report on how we got here is in the files (structure). Org chart needs some work.

Budget See report. We lost a few pledging units. Followup will happen. Initial goal was high (+6.5%) came in at +2%. Discussed different options, and implications of changes. Faith In Action and Community Life position salaries are still throwbacks to Pastoral size church. Essentially getting a stipend, with lots of volunteer time. For program size church, we need staff to fill these roles more effectively.

Community Life position hiring was not originally successful, was reposted, and we got one application who is ready to start.

Discussion - on alternative revenue, adding more resources on e-sales, and that PNWD has a Growth Fund (Mary is on the board). We could make a grant application to the fund to increase in the budget. Mary proposed a revenue task force. More discussion on options & clarifications. One option to do a direct appeal to the congregation – this has been done before. If we drop UUA dues for one year, we can do Plan B with no change.

Decision – Adopt Plan B and drop UUA dues – would drop UUA dues to ~\$6000 and make a balanced budget. **Unanimous approval**

Discussed redrafting bylaws to change the FY to July-June in July 2020. We will plan to amend bylaws for the FY in Spring meeting, and work on calendaring before then for a presentation to the congregation.

Community life person will be on contract for a few weeks until the 8th, pending budget approval.
